## A Local And National ZBT Mainstay, Graham '37 is Honored by the Chapter

If an effort to enumerate the brothers who have contributed abundantly to the dignity and prestige of Kappa Chapter were to be made, the list would be too long to include in this limited space. In this issue, the spotlight is on Richard S. Graham '37, a Zeta Beta Tau mainstay, both locally and nation-

Graham received his degree from Cornell's School of Arts and Sciences in 1937, and was vice president of Kappa Chapter that year. He has been a trustee of his chapter since 1938 and vice president of the Kappa Foundation since

He has served on the Supreme Council since 1948, when he was elected a director of the Mideastern Region. He is a member of the National Prizes Committee, having served as chairman for five years. In 1949 and in 1954 he was chairman of the "Going-Away-to-College" rushing smoker in New York

Graham was National treasurer in 1949-50, and became National vice president in 1953, and has continued to serve in that capacity. He is a member of the Finance Committee and was its chairman in 1949-50, and is now chairman of the Chapter Expansion and a member of the Chapter Welfare Com-

He was president of the New York Alumni Club in 1949-51; is secretary and director of Zeta Beta Tau Foundation, Inc., and a member of Sigma Delta Chi.

Graham enlisted as a private in World War II, and was injured in the Battle of the Rhineland in Germany. His decorations include the Bronze Star, with "V" for Valor.

While at Cornell, he was in the



Drama Club for four years; in freshman crew, the freshman and varsity swimming squads, the Cornellian board, SURW, and the Men's Cabinet.

Graham is an executive of Reynolds and Company in New York City, member of the New York Stock Exchange. He is married and has a son and daughter.
