# R. Stein Exemplifies Kappa Qualities

Richard Allen Stein, who was graduated from Cornell earlier this month, has been in many ways untypical of the average Cornell undergraduate, be he fraternity man or independent. During his four years on the Hill, Dick has managed to achieve that rare but ideal combination — an above-average scholastic ability with a high degree of service to both his fraternity and the University.

#### Typical of Kappa's

But as singular as Dick's achievements may appear when contrasted with those of the average undergraduate, we feel nevertheless that they are somehow typical of all Kappa's. We have thus chosen to feature Dick in this issue of The Edgecliff News not so much because he is an outstanding senior (which he certainly is), but because he presents an accurate picture of today's Kappa undergraduate - a young man who is getting the maximum of the many advantages offered him by college and fraternity life.

A native of Chicago, Ill., Dick has proven himself an outstanding student in the School of Hotel Administration. He has been a member of the School's Hotel Sales Management Association, has taken an active part in Hotel Ezra Cornell, which is held annually for visiting hotelmen throughout the nation, and belongs to Grin & Grip, the School's honor society.

#### Gains Summer Experience

During the past two summers, he has worked hard at gaining additional experience at the Ambassador Hotels in Chicago and Los Angeles. At both hotels, he was in the food and beverage control department.

Dick has played a leading role in various student government bodies at Cornell. He has been vice-president of the Interfratern-

ity Council and has served with distinction on two of the student Government's most important committees, the nominating committee and the scheduling activities review board.

He has also served Zeta Beta Tau well, both as vice-president of the house and in many official and unofficial capacities. These varied activities, along with Dick's unfailing enthusiasm and interest in Cornell, have resulted in his being elected to many honor socities, the most important being the senior honorary, Sphinx Head.

Itivities were recognized last May when he was awarded the Theta Delta Chi Award for showing outstanding "qualities of leadership and achievement." This award is presented annually by the fraternity to a senior who, while not a member of the fraternity, best extemplifies the characteristics Theta Delta Chi expects to find in its own members.

We are proud to report that our leadership extends not only into the fields of scholarship and extra-curricular activities, but also includes the management and condition of the house.

#### Maintain Academic Standards

Although as of press time, the comparative academic standings of Cornell fraternities had not yet been released by the Dean's Office, we feel confident that last year's excellent record has been maintained. At the end of the last academic year, you will recall. Kappa ranked third in the overall scholastic ratings of fraternities, with an average of 77.80. Our good academic standing is reflected in the election of Eric A. Nordlinger '61 to Arts & Sciences' highest scholastic honorary, Phi Beta Kap-

As has been noted elsewhere in this issue, Kappa's participation in extra-curricular activities continues to be at a high level. Perhaps one example will be sufficient to point up the leading role we play on the campus. In March, three ZBT brothers were elected to important posts in student government organizations. Thomas A. Rothschild '62 was elected president of the Executive Board of the Student Government, George C. Gorman '63 was elected one of two fraternity representatives on the Executive Board, and Jules B. Kroll '63 was chosen treasurer of the Interfraternity Council.

## Alumni Directors Hold Annual Meeting; Consider Chapter, Foundation Problems

The Board of Directors of Kappa Foundation, Inc. held its annual meeting May 24 at the Cornell Club in New York City. The meeting immediately followed the annual meeting of the members of the Kappa Foundaton, Inc., which was also held at the Cornell Club.

The meeting was called to order by Eugene M. Kaufmann, Jr. '26 who acted as chairman. Theodore W. Adler '28 served as secretary of the meeting.

#### Kappa Officers Elected

Following the acceptance of the minutes of the previous meeting, the following slate of officers was presented: Chairman of the Board, Eugene M. Kaufmann, Jr.; President, Richard D. Turteltaub '48; Vice Presidents, S. Robert Sientz '30 and G. Ury Gants '35; and secretary-treasurer, Theodore M. Adler. The entire slate was unanimously elected to office for a one-year term.

Among the more important items of business to be considered by the Board were those dealing with the finances of the Kappa Foundation and the Chapter. The Board approved a recommendation by the Treasurer that the financial statement covering the New York Foundation bank accounts be submitted each year to all Kappa alumni at the time of mailing of the dues letter. The financial condition of the Chapter was found to be excellent.

#### Summer Repairs Planned

Also approved by the Board was an authorization to the Chairman to expend up to \$5,000 during the summer for necessary repairs, improvements and furnishings for the Chapter House. The recommendations for repairs and improvements were contained in a report, prepared by the University and read by the Chairman, on the condition of the House. The findings of the report were that the house was in generally good condition.

The decision to engage the services of Mr. William S. Downing,

Jr., an Ithaca architect, to supervise the maintenance of the building and the purchasing of furnishings and installations was ratified by the Board.

The Directors also discussed the "legacy" problem in pledging. It was announced by the Chairman that the Executive Committee of the Chapter had put into effect a ruling that the son of a Kappa Chapter Alumnus would automatically be pledged, subject to the approval of the Executive Committee. The Board expressed its gratification at this action.

The final item of business before the meeting was adjourned dealt with the presentation of this year's annual Scholarship Award. It was decided that the Award be granted to Jules B. Kroll of Bayside, N.Y. He will be a Junior next year and is enrolled in the College of Arts & Sciences.
