## President Reports Successful Year

It is with great pleasure that I take this opportunity to tell you of the banner year which Kappa has just completed, a year which has proved to be the chapter's most successful since the remarkable revival of 1975. This year's success is extraordinary in the light of the hard times which were expected. Kappa was in financial difficulties and had a hard time in making ends meet. However, the brotherhood pulled together and managed well. It is hard to believe that just five years ago the house at Edgecliff was empty, gathering dust instead of serving as a home for the brothers of Kappa as it should have. It took a dedicated and farsighted group of national representatives and undergraduates to re-establish ZBT at Cornell. The next few years proved to be a long uphill battle, but the chapter survived through the efforts and sacrifices of the brotherhood. I must emphasize the word "survive," for survival was the goal of those first years.

In my two years as a Kappa, I have seen the chapter grow from a house struggling to exist to one which is a thriving fraternity. The past year has seen Kappa make its mark on the university as one of the finest fraternites on campus. As a result of a spectacular rush effort, last spring we initiated 16 new brothers, the largest class taken since the chapter's new start. The brotherhood has also been active in community service as it continues to be involved with the Ithaca Youth Bureau's One to One Program. The chapter has made it a tradition to hold annual parties for the children on Halloween, Christmas and Easter. The house has also been active athletically, fielding teams in many intramural sports against Cornell's 40 other fraternities. Kappa is especially proud of the role it has had as a host for other ZBT chapters. In the past year brothers from Columbia, Union, Alfred and Fairleigh Dickinson University have visited Edgecliff to enjoy a weekend with Kappa.

The year culminated in the chapter's spring dinner-dance. The brothers and their dates enjoyed dinner and dancing during the last weekend before final exams. The evening was followed by a picnic the next day at Taughannock State Park.

At a glance the year was a tremendous success. However, the brothers have often been frustrated in their attempts to improve the house at Edgecliff. Now over 50 years old, the house is showing its age, and is badly in need of electrical and plumbing work, fresh painting, new furniture and many other capital improvements. # Edgecliff To Be "Revitalized"

As predicted, this past year was an immense struggle for the Chapter and thus the Foundation. The departure of the 1978 graduating class of 22 (the founding brotherhood of the modern Chapter), compounded by an overall poor rush season at Cornell, left Kappa with a low membership. Always a revenue problem, the Chapter House (Edgecliff) was not filled. Because of this a 10% budgetary cutback was enacted for the Chapter and Foundation. When the year started I questioned the Chapter's ability to remian within its budget. Thus I steered the Foundation on a course to bail out the Chapter at year's end. This meant making only essential repairs, minimum maintenance and no improvements.

To my surprise and glee, the men of Kappa operated well within their budget. At this time it goes without saying that Kappa Chapter and the men who compose it have a tight rein on the operating of their fraternity.

Because of the Foundation's and Chapter's conservative monetary policies, Kappa Foundation ran a profit for the 1978-1979 fiscal year. This surplus will be deposited into the general building fund earmarked for capital improvements. Great capital improvements are planned for the 1979-80 budget, but all extra funds certainly help.

A great period in time has finally been reached by both Kappa Chapter and Kappa Foundation. Although Kappa Foundation is the "long term fraternity" i.e. Kappa Chapter's Benefactor, the Foundation's success depends 100% on the support of Kappa Chapter. The long term institution cannot function without the short-term cooperative interaction with the Chapter. I am happy to state that such is the case.

Without question Edgecliff is an inefficient plant to maintain. Several times the idea of moving to another house has come up. The decision has been made — Edgecliff is ZBT at Cornell and that will not change. With this comes the only other decision — Edgecliff must be renovated for efficiency and cosmetic appeal. Our inherited debt has to this point kept us from making these alterations. Now that the Chapter and Foundation have both feet solidly on the ground efforts in this respect must be tackled.

Because of inflation and the general inefficiency of the house ZBT is beginning to price itself out of the Cornell fraternity market. Presently, for what is offered, ZBT is the highest-priced fraternity at Cornell. By this I mean public rooms are relics of the 1940's, draperies are tattered, and springs poke through the furniture while the walls are in desperate need of painting. The Chapter is rushing a high quality of young Cornellian. These new brothers deserve the best affordable living conditions possible. So, since we cannot lower prices, we must offer more goods for the dollar; then we may justify an increase in our fees.

The following imporvements are planned for the Chapter House. The Richard S. Graham Library will be redecorated with new curtains, repainted, a wall paneled, and furniture purchased. Mrs. Richard S. Graham has generously assisted to make this possible. The chapter room will be totally outfitted. New furniture has already been ordered. Painting, lamps, and curtains are also on the list. Entirely new to Edgecliff will be a pool table. This comes through the individual contributions of the brothers. One brother in particular, Petur Hansson '82, the chapter steward, generously donated his steward's stipend to make the pool table a reality. General plumbing, electrical work, beds, desks, chairs and other study aids are also necessary. Also, to cut heating costs, the idea of storm windows is being investigated. Because of cost these will be handmade by the brothers.

As you can imagine, this is quite an undertaking. I don't hesitate to say that this cannot be accomplished without Alumni support. This coming fall the Chapter and Foundation will conduct the most extensive fund-raiser in Kappa's 72 year history. When you receive a call from a fellow classmate of years ago, remember all the good times that ZBT — Edgecliff — gave you; then help Kappa to continue providing those good times to Cornell Kappas of today. Arrangements have already been made to keep all donations TAX DEDUCTIBLE. Your annual membership to Kappa Foundation (Alumni Dues) only provides enough revenue to keep Edgecliff News coming to you.

For rush and before Alumni Weekend I hope to have Edgecliff once again one of the classiest houses at Cornell — it already has the best brothers.

I close by saying that Kappa Foundation's quest for the coming year is revitalization — the revitalization of a structure with great memories of the past to include the comforts of the present.

I'll expect you all to celebrate our achievement with us this Alumni Weekend — Homecoming, November 3. Until then, I leave you.
